- ▶ The MAM-BGR agreement that BGRs entered into with GCA in its role as MAM will be transferred to AGGM

- ▶ No changes in terms of regulatory framework
 - ▶ Except for new parameters of the balancing incentive mark-up
- ▶ No changes in terms of operational procedures
 - ▶ GCA remains in operation as dispatching service provider for AGGM
 - ▶ The MAM-Online-Plattform will stay unchanged in terms of structure and usability
 - AGGM corporate identity will be applied
 - Further content development will take place later on in cooperation with market participants, system operators and regulatory authorities

- ▶ AGGM contracted GCA to provide MAM dispatching services as of 1st of June 2017
- ▶ 1st level support will still be given by GCA as the service provider for AGGM
 - ▶ Therefore your operative contact persons at GCA will remain unchanged
- ▶ AGGM additionally will provide a 2nd level support

 - ▶ Planned to be extended with further data from the Market Areas Tyrol and Vorarlberg and from the Distribution Area East
- ▶ News and REMIT
 - ▶ Planned to be harmonized with News and REMIT communication of AGGM in its role as DAM

- ▶ In addition to the coordination of maintenance works in the distribution system, AGGM will take over these coordination activities also in the transmission system
- ▶ Annual coordination process of maintenance activities
 - ▶ 1st of August: MAM sends questionnaires to TSOs & SSOs
 - ▶ October: Coordination meeting with TSOs & SSOs
 - ▶ 15th of Nov.: Publication of the “Integrated Maintenance Schedule” including capacity reductions
 - ▶ Updates during the year possible
 - ▶ Planned harmonization with coordination process of maintenance activities in the distribution system

- ▶ This years process already started and is well prepared
- ▶ Timeline:
 - ▶ Kick off: March 1st, 2017
 - ▶ GAS CONNECT AUSTRIA prepared the CNDP 2017 project plan
 - ▶ AGGM goes MAM: June 1st, 2017
 - ▶ Definition of capacity scenario in June
 - ▶ Further coordination between stakeholders during summer
 - ▶ Stakeholder Joint Working Session (SJWS): September 5th, 2017
- ▶ **Long Term Planning and Coordinated Network Development Plan** will be prepared in the same timeline.
